LICENSE AGREEMENT

In return for payment of the applicable fee, Hewlett-Packard grants the Customer a license in the software, subject to the following:

USE OF SOFTWARE

- Customer may use the software only on a single printer at one time.
- Customer may not alter, reverse engineer, disassemble or decompile the software.

COPIES

- Customer may make copies of the software:
 - a) For archival purposes; or
 - b) As part of the automated installation process which copies the software to the hard disk.
- All copies of the software must bear the copyright notice(s) contained in or on the original.

OWNERSHIP OF SOFTWARE

- Customer agrees that it does not have any title or ownership of the software, other than ownership of the physical media.
- Customer acknowledges and agrees that the software is copyrighted and protected under the copyright laws.
- Customer acknowledges and agrees that the Printer Resources, Utilities, page
 description language interpreter, and encoded font programs have been
 developed by third party suppliers named in the copyright notices included
 with the software, who shall be authorized to hold the Customer responsible for
 any copyright infringement or violation of this License Agreement.

USE AND OWNERSHIP OF TRADEMARKS

- Customer agrees that the trademarked typeface names can only be used to indentify or make reference to printed output produced by the software in conjunction with the coded font program identified by the trademark name and not to identify any other typeface, and customer agrees to follow accepted trademark practice when referring to the trademark.
- Customer agrees that use of any trademark as authorized in this License
 Agreement does not give the user any rights of ownership in the trademark.

TRANSFER OF RIGHTS IN SOFTWARE

- Customer may transfer rights in the software to a third party only as part of the transfer of all rights and only if Customer obtains the prior agreement of the third party to be bound by the terms of this License Agreement.
- Upon such a transfer, Customer agrees that its rights in the software are terminated and that it will either destroy its copies or deliver them to the third party.
- Transfer to a U.S. government contract shall be made only upon their prior written agreement to terms required by Hewlett-Packard.

TERMINATION
